TWICKENHAM STATION: PLANNING APPLICATION (Ref: 11/1443/FUL) and (Ref. 10/3465/FUL)

Further to my previous letter dated 1 August 2011, we have decided to re-issue the whole pack of information in response to the Regulation 19 Request, which now includes the updated socioeconomic chapters (with figures) and the sunlight and daylight reports. For ease of use, this pack replaces the previous pack issued on 1 August 2011.

Enclosed with this letter are two 'Master' responses to the Council's Regulation 19 Request, one for each application (10/3465 and 11/1443 respectively). These include details of previous information issued and where the responses are located (i.e. transport addendum, Construction addendum etc).

The Master document for the smaller scheme has also been updated to clarify that the larger scheme was assessed to have a *negligible impact* in terms of impacts on ecology from overshadowing on the River Crane. Consequently, overshadowing of the River Crane Corridor and wind is not a significant environmental issue in relation to ecology. It follows that overshadowing of the River Crane corridor and wind as a result of the smaller scheme (11/1443/FUL) is likely to have *less impact* on ecology than the larger scheme and, therefore, as the larger scheme represents the worst case scenario, the conclusions of the Ecology Chapter are robust for both schemes.

- 2. (ES Chapter 6) Construction addendum and updated Gantt chart;
