## **DETAILED REASONS**

#### U04530 Reason for refusal

The proposed building by reason of its size, visual character, location and necessary loss of trees and greenery would be an intrusive form of development resulting in loss of an area of Metropolitan Open Land, visual detraction from the remaining Metropolitan Open Land, and loss of vegetation which currently provides benefits from its functions as a visual screen and as wildlife habitat. The proposal would thereby be contrary to policies ENV 3, 8, 17 and 19 of the adopted London Borough of Richmond upon Thames Unitary Development Plan and ENV 1, 9, 19, BLT 11 of the emerging London Borough of Richmond upon Thames Unitary Development Plan First Review.
