DETAILED REASONS

U54778 Refusal - Condition 6.

The proposed site investigation and contaminated land assessment, by reason of its inadequate spatial coverage of sampling and insufficient/absence of data relating to groundwater quality and soil vapour, represents a partial and unsatisfactory document which in all likelihood would result in ineffective decontamination measures being adopted at the site thereby rendering the site unsuitable for residential use. The propsal is therefore contrary to policies CP1 of the Core Strategy 2009, DMSD1 Development Management Plan 2011 and Sustainable Construction Checklist: SPD.

U54782 Refusal - Condition 3

The details submitted pursuant to Conditon 3, by reason of their lack of information and in particular the failure to provide a sample panel of brickwork on site, do not demonstrate that the resultant development would preserve or enhance the character and appearance of the Conservation Area and the Building of Townscape Merit itself. Accordingly, the proposal is contrary to policies DM HD1, DM HD 3, DM HO1 and DM DC1 of the Development Management Plan, Core Strategy Polict CP7 and the Supplementary Planning Document Design Quality.

U54783 Refusal - Condition 5

The details submitted pursuant to Conditon 5, by reason of their lack of information and unacceptable height of the boundary treatment along the boundary with properties in Talbot Road do not demonstrate that the resultant development would preserve or enhance the character and appearance of the Conservation Area and the Building of Townscape Merit itself. Furthermore, the proposed trellis to the rebuilt/repaired boundary wall would result in an overbearing and visually intrusive form of development for the occupiers of properties in Talbot Road. Accordingly, the proposal is contrary to policies DM HD1, DM HD 3, DM DC5 and DM DC1 of the Development Management Plan, Core Strategy Polict CP7 and the Supplementary Planning Document Design Quality.

U54784 Refusal - Condition 12

The details submitted pursuant to Conditon 12, by reason of the inconsistencies between the submitted layout plan and the layout plan approved under the parent permission ref 10/1691/FUL together with the unsuitable location of the Amelanchier Lanarckii trees are such that the information submitted is cosnidered unsuitable to discharge the application for approval of details as submitted. Accordingly, the proposal is contrary to policies DM HD1, DM HD 3, DM DC4 and DM DC1 of the Development Management Plan, Core Strategy Polict CP7 and the Supplementary Planning Document: Design Quality.

DETAILED INFORMATIVES

U63549 Advice - Contamination

In view of the current situation on the site and as a possible solution to the current lack of data within the Power Station area it should be possible to include a ground gas and soil vapour protection membrane / barrier as part of any new floor slab. Essentially an upgraded damp proof membrane which is as important as a well installed concrete floor slab in terms of providing a barrier to any potential ground gases / soil vapour. Any membrane installed must also be independently validated as being installed correctly. Such membranes are available from a variety of suppliers including Visqueen (http://www.visqueenbuilding.co.uk/ourproducts_details.asp?catid=2&productid=18) and Industrial Textiles& Plastics Ltd (http://www.itpltd.com/en/product/puraflex-hydrocarbon-chemical-resistant-barrier).
