#### U58213 Reason for refusal

The proposal by reason of the demolition of the coach house would fail to preserve or enhance the character and appearance of the Sheen Road Conservation Area by losing important historic local building and which would be detrimental to the setting of the neighbouring Building of Townscape Merit, contrary to policy CP7 of the adopted Core Strategy 2009, and polices DM HD1 and HD3 of the Development Management Plan 2011.
