#### 1 INTRODUCTION

This is the Planning Statement included in a suite of documents prepared in support of a Planning. Application for the construction of a turbine to generate renewable energy on Teddington Weir. It is not very often that the opportunity to install such a structure is made available. We believe that this project has the potential to realise the renewable energy goals, not only of the Council, but also of many interested residents. The project is potentially transformational in nature. It could act as showcase for community energy, inspire pride, and provide interest and delight to walkers along the Thames path and to other individuals and bodies.



### 2 THE PLANNING CONTEXT

Richmond Council gives a high priority to 'green' and sustainable development. The Core Strategy (adopted by the Council in April 2009) makes reference to a number of criteria for the promotion and enhancement of the Borough through green and sustainable development. We believe that the promotion of a hydro power scheme on the Thannes exactly meets the criteria set out in this document and set cut the following examples in support of our case:

- The Core Strategy sets out a vision for the Community Plan that would like to see the Borough; 'inclusive, green, safe and responsive'.
- · Priority 2 of the plan is 'Being the greenest borough in London'.
- The objectives of the Local Plan Agreement include the statement; 'we want to continue to build on the sustainability of our communities and to protect our environment for the future.'
- Within the Core Strategy, section on Local Development Framework Vision again includes a
  reference to a sustainable future; 'The Borough's responsibility to global sustainability'. In
  particular, the aspiration is described by 'energy use minimised and renewable energy
  maximised'.
- Item 4.4.9. Climate Change notes: 'Climate change is the most important factor facing the World....... The Borough aims to become a leader in the development of sustainable lifestyles. Opportunities for de-centralised energy production will be considered'.
- Item 6.1.2 highlights the priority to play a role in minimising climate change, measures to minimise energy use and encourage the use of renewable energy.
- Item 8.1.2.2 States: 'All new buildings to include the use of renewable energy sources'.

We believe that the application to install our scheme on the Thames at Teddington Weir aligns with the Council's priorities with regard to sustainability, renewable energy and climate change. In this context, we unge the Council to give a favourable consideration to this Application.



### 3 SPECIFIC PLANNING ISSUES

A previous application for this development, submitted some two years ago, is now withdrawn and this application with required minor improvements is submitted in its place.

Discussions between the Council, Ham Hydro community interest group (ECI, Teddington & Ham Hydro Cooperative Initinet, The Lenknyary and various virus erus sets resulted in revisions and Hydro Cooperative greater sets and application. The designs have also evolved to reflect the concept with greater maturity and integrity than that previously submitted, But the fundamental principles and the rationale for the project have not changed and these points are explored in this and other, related documents.

The design has been prepared to the level suitable for a Detailed Town Planning Application. Consultant Engineers and designers, as well as our own team, have contributed to this process. From this, the Environmental Impact, particularly with regard to noise, is reported. Pre-application consultation has been undertaken with the Environment Agency and the design has been modified to now include a fink and sell pasts.

### Full environmental impact assessment not required

Richmond Council informed us that a Full Environmental Impact assessment is not required.

However, we have closely consulted with the Environment Agency on a number of issues to ensure our scheme will not be detrimental in any way to the environment. As part of this we have written a Water Framework Directive Assessment, which is not a requirement for this planning application, but is available from our website for interested parties, though we should note it runs to over 100 pages. This work and consultation has led the to specific assurance from the Environment Agency that it is supportive of our scheme. We attach their letter dated 3rd July 2013 in the appendices, and here is a relevant quote from that letter:

### Detailed design

Whilst we are confident that the design meets all known requirements and constraints, it may be that further detailed analysis will require design revisions to be understaxen. ### 4 OUR REASONS FOR UNDERTAKING THE PROJECT

The team believes that we, as a community, should be taking local action to make a contribution towards combating climate change and generating decentralised renewable energy. The flow over Teddinaton Weir allows for the possibility of generating clause, neprevable energy.

The Environment Agency is the landlord of Teddington Weir and opened up the possibility of developing hydro power on it in April 2010. The team formed a non-profit organisation to bid for the exclusive rights to develop a project there. We were successful and have been working ever since to develop a workable design.

Once buil, the scheme will produce between 1.5-1.95Wh of electricity. This power will be exported into the grid, rather than directly power local homes, but in order to help understand the amount of power the scheme will produce, this is enough to power roughly 600 homes at the upper end, or around 80% of the energy requirement of Richmond Borough's Schools and reduce carbon emission by enarly 1.000 conness ser wear.

### Community Owner - Aligned with government objectives

The scheme will be community owned, with community investors benefiting from the financial benefits of energy generation through variable interest payments on their investments. This aligns with the policy objective of both the previous and current government to incentivise community-owned renewable energy. Indeed, the Department of Energy & Climate Change recently published its Community Energy Strategy which promotes and incentivises individuals and communities to generate and export renewable energy through the system of feed-in tariffs, for which our scheme is

In addition to this, 10% of profits will be gifted to the Teddington & Ham Hydro Foundation, which will seed other renewable and fuel poverty alleviating projects locally.

As a result, we think that our project will not only provide a compelling social return, it will also provide an attractive financial return.

#### A strong parchage

The forecast revenue from the project (a mixture of FIT payments and sale of electricity) will, after associated costs, pay back the capital costs within 10-11 years. The lifetime of the asset is expected to be 40-50 year or more, so the directors consider this to be a good, long term investment.

### How much will you need to raise to build the scheme?

The cost to build the scheme is forecast to be £3.7m. However, we are budgeting for a 10% contingency and so will be raising £4.2M.

### What are the impacts on fish and the fragile river ecosystem? How will they be mitigated?

We have commissioned reports assessing the potential areas of concern in the weir pool and its immediate surroundings which show that the operation of the scheme under EA-imposed operating conditions will not have a detrimental impact on the local environment.

A flood risk assessment has been carried out by our consultants which shows that there will be a "negligible" impact on flood risk.

#### What about fish passage?

The Archimedean turbine allows fish to pass through it without being damaged. Please refer to http://www.fishtek.co.uk/hydrogowerresearch.html for further details.



The scheme also includes a new fish pass, 3.6m in diameter, to replace the two existing Im-wide ones. This new fish pass will include multiple gradients to enable the migration of a variety of species. This will be a significant improvement on the current situation for fish migration. In addition, we will install an eel pass.


