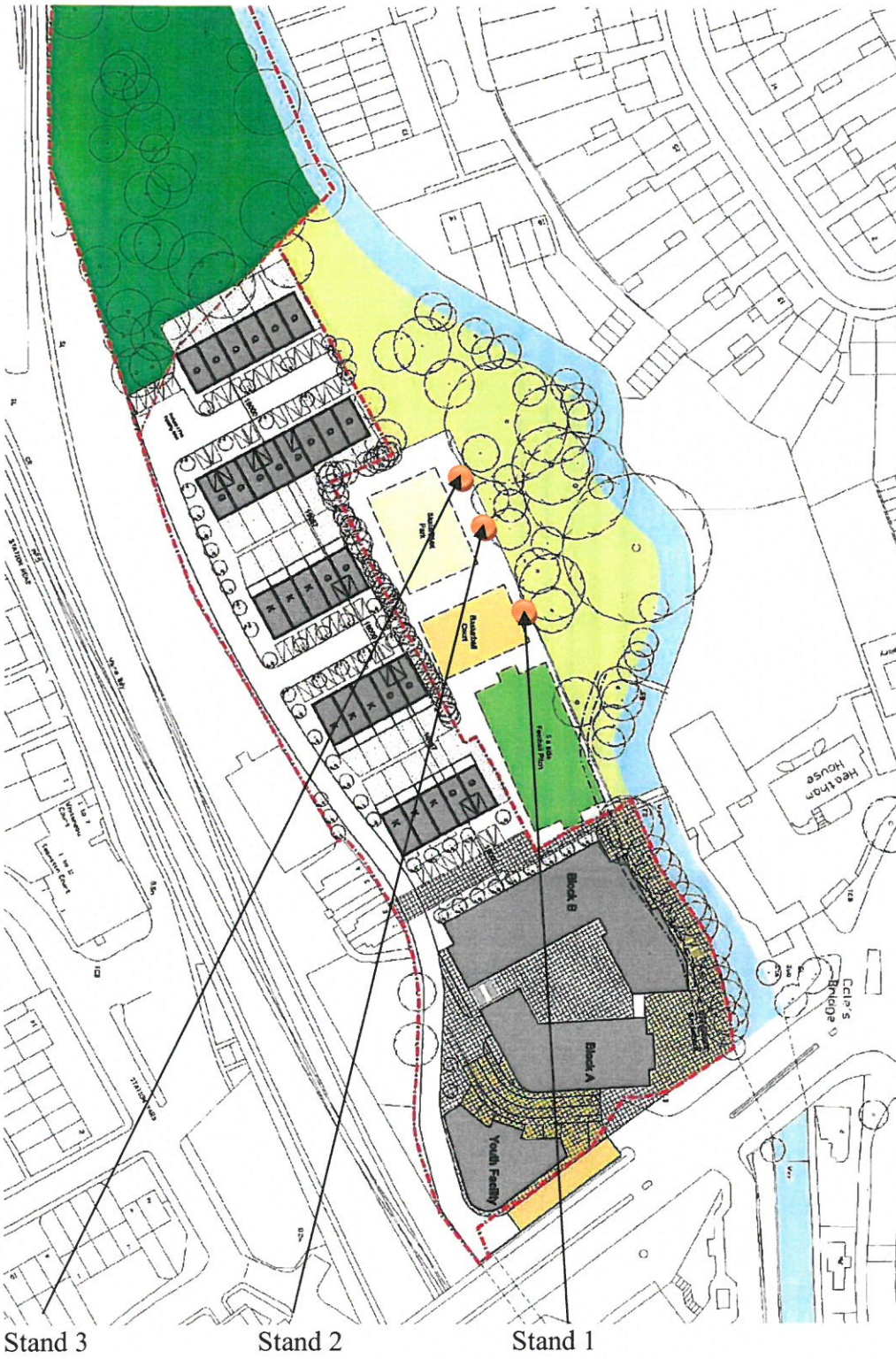
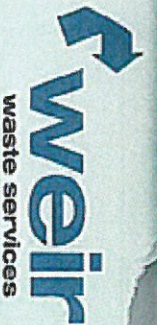

Appendix E (Site Plan with Specific Locations)

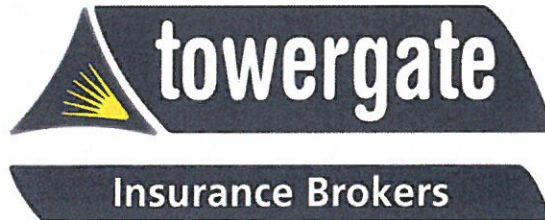

DUNTON ENVIRONMENTAL LIMITED

WARRANTY FOR THE ERADICATION OF JAPANESE KNOTWEED

This Warranty is given to St James Group, (“the Beneficiary”) in respect of the treatment of Japanese Knotweed on a site in specific locations shown on the drawing annexed hereto.

Dunton, for the payment of £1 (one pound) from the Beneficiary to Dunton, receipt of which Dunton hereby acknowledges hereby warrants and undertakes to the Beneficiary pursuant to the contract (‘the contract’) with Dunton Environmental Limited of Unit 1, Tamebridge Industrial Estate, Aldridge Road, Perry Bar, B42 2TX (‘Dunton’) the following:

- 1) Dunton Environmental has designed, carried out and completed such treatment of Japanese knotweed as Dunton Environmental has seen fit to ensure that the eradication was successful in the specific locations in which Dunton Environmental carried out treatment works.
- 2) If there is any evidence that the treatment has not been successful despite the above, Dunton Environmental undertakes to take such reasonable further steps as shall be necessary, to eradicate the Japanese knotweed.
- 3) If the Client requires greater insurance cover than the above, it must in its own interests arrange such cover.
- 4) Dunton Environmental does not accept any liability for the emergence of any Japanese knotweed that has been introduced from offsite sources or which has grown outside the specific locations during the period of the treatment or for the period of this Warranty.
- 5) This Warranty does not confer any rights other than expressly set out above and does not cover any claims for consequential loss or damage.
- 6) Dunton Environmental issues the Warranty and any claims under the Warranty shall be made against Dunton Environmental for breach of professional duty. If Japanese knotweed re-grows in the specific locations treated by Dunton Environmental, then Dunton Environmental undertakes to retreat the specific

locations using all reasonable methods, unless the cause of the re-growth is due to the actions of a third party as per clause 4.

- 7) Dunton Environmental confirms that Dunton Environmental has professional indemnity insurance covering its liabilities under the contract with a limit of indemnity of not less than £5,000,000 (five million pounds) for any occurrences arising out of each and every event. Dunton Environmental will maintain such insurance at all times until two years after the completion of the treatment provided such insurance is available in the United Kingdom on commercially reasonable rates and terms. When reasonably requested, Dunton Environmental will provide documentary evidence that the insurance required under this Guarantee is being maintained.
- 8) Dunton Environmental accepts liability only for specific locations treated by Dunton Environmental and Dunton Environmental accepts no liability for Japanese knotweed brought to the Site after the Treatment has been completed, or that may grow in an area outside of the original specific locations.
- 9) Subject to the terms set out above, this Warranty shall remain valid for a period of **two years** from completion of the Treatment.
