

#### **DETAILED CONDITIONS**

#### U29917 Re-Planting

One replacement tree will be required, to be planted within 3 metres of the location of the original tree (\*T1 - Leyland cypress) during the next available planting season (October 2017 to March 2018) following its removal.

The tree must be a nursery container grown standard with a minimum girth of 10-12cm (measured at 1 meter above ground level) and planted in accordance with good horticultural practice and maintained to ensure establishment. The tree must be planted in accordance with the Code of Practice for General Landscape Operations BS4428 1989. The replacement tree species should be: Hornbeam, Beech or Pear.

Should you wish to plant in another location, please contact the Tree Section for advice. Any change of position must be agreed in writing with the Local Planning Authority. If the replacement tree should die, is found dying or becomes diseased within 3 years of being planted, it must be replaced again, conforming to the details of this condition.

Please contact the Tree Section to inform us of when you have planted the tree so that we may visit and inspect. Alternatively you may email a photo of the planted tree to email address (Trees&Parks@RichmondandWandsworth.gov.uk).

Reason: To ensure the continuation of the tree cover in the locality.

#### U29918 Tree work standards

The works must be carried out in accordance with British Standard 3998:2010, 'Tree Work - Recommendations'. Reason: To safeguard the health and visual appearance of the tree(s) and to ensure the works are carried out in a safe and controlled manner. #### U29919 Timescale for work

The works hereby permitted must be carried out within one year from the date of consent. In the event of the works not being completed by that date, a further application to and prior written consent from the Local Planning Authority will be required. Reason: To ensure the works are carried out in the most appropriate time frame.
