## Amendments to the report:

- Under 'Proposal' substitute '23 flats' with '22 flats'.
- Under 'Summary of Application', second line substitute '23 flats' with '22 flats'.
   and under Recommendation 2 substitute 'reason' with 'reasons' and add a second reason for refusal:

In the absence of a binding agreement to secure affordable housing provision which meet the aims and requirements of Council policy the proposal would be contrary to policy DM HO 6 of the Richmond upon Thames Development Management Plan 2011, policy CP 15 of the Richmond upon Thames Core Strategy 2009, Pre-Publication Local Plan Affordable Housing policy LP 36 and Supplementary Planning Document 'affordable housing'.

- Paragraph 20 add 'This has resulted in the removal of a one-bed flat leaving the overall total number of flats as 22 (eleven one-bed and eleven two-bed).
  - 'There is also an amended drawing confirming a green roof and another showing the street level floor wholly as offices (it had been mistakenly shown as a cycle shop).'
- Paragraph 21 add third bullet
- Secure the tenure of the flats for shared ownership to ensure that the scheme retains affordability and the normal marketing requirements specified by Council housing policy are adhered to.
- Paragraph 41 substitute '23 flats' with '22 flats'.
- Paragraph 45 add 'This will need to be secured by a legal agreement'.
- Under 'Conclusion' substitute '23 flats' with '22 flats'.
