T217 Horse Chestnut - Reduce north side laterally

T218 Horse Chestnut - Crown reduce by 2.5m on north side and remove deadwood

T233 Horse Chestnut - Crown reduce by 2.5m and remove deadwood and pollard large south west limb to primary pollard points

Cedar - Crown reduce by 3-4m on all aspects to lessen windthrow
