
I raise the following objections to the development:

- The nature of the housing planned is not appropriate: too high a density of housing and a percentage of affordable housing below the council's guidelines, delivered towards the end of the building project and with limited guarantees that it will materialise on this site.
- 3. The significant detrimental impact on transport that will be caused by this level of development, a significant increase in journeys by users of the development (housing, school and retail units), and the very limited contribution of the developers to ease this. I am particularly concerned by the increase in car journeys on already polluted and congested roads, the impact on pollution and ease of movement, as well as the lack of increase in planned public transport to serve the community.
- 4. The potential inclusion of high need units without a contribution from the developers to increasing the healthcare provision in the local area, or any other support to the local infrastructure which will come under significant strain if, as a result of this development, the population of Mortlake is increased by around 40%.
- 5. The inclusion of a large new secondary school for which I do not believe there is a demonstrable need and which therefore would damage the existing secondary schools in the local area, RPA and Christ's. The provision of secondary school places but no primary school places is also a significant gap in the plans.
- The reduction of green space as a result of the development will have a significant negative impact on air quality and our ecosystem and therefore the health and quality of life of people who live in our area.
