I wish to object to the Stag Brewery Development as it is planned for several reasons outlined below. Whilst I believe the area should be developed, the number of residential units should be reduced by half and each should have 2 on site parking spaces. No street parking CPZ residential parking permits should be allowed whatsoever. No properties should be allowed to be purchased via an SPV to avoid tax. No school should ever be placed on the playing field which should be handed to the community as a legally protected village reen. There should be no special provision of extra road access to the A316 and the 209 Bus terminus should not be moved there either.

The proposed residential development is too dense for the plot size and is designed for maximum profit to the overseas developer with no informed consideration with regards to middle or lower income or social housing. Many of these properties will be purchased in by overseas investment companies in an SPV to avoid tax and will remain empty.

No land or trees should be carved off in Clifford Avenue to allow residents from the development to jump the queue in their cars in order to access the A316. The residents of Chertsey Court are already subjected to too much noise and pollution as it is. Air pollution is very poor and the trees remove carbon dioxide so why remove the land barrier and trees?

The provision of a school in such a compact and congested site previously used by local residents to exercise is very short sighted. If Richmond Council allow this part of the development to succeed it will be purely because they have to provide another school somewhere in the borough and not because this is a suitable site. This is clearly a softener deal with the developer who wants to build significantly more residential units than previously indicated and Richmond Council should be objective in rejecting this bribe.

Obesity is at epidemic proportions in this country and this playing field area should be kept clear as an exercise field. We already have teachers of children from Thompson House primary school chasing the public off areas of Mortlake Green just so the pupils can exercise in private on so called public land and now you want to remove another safe exercise area. Insufficient parking for teachers, none for parents and pupil drop off areas will significantly add to rush hour congestion.

NO CPZ PARKING PERMITS whatsoever should be issued to anyone living or working in the Stag Brewery Development as it is a new residential development.
