I believe that the traffic, including lorries that take a short cut through the area, instead of remaining on the South Circular, should be stopped. This would help to alleviate the problem.

Another lane of traffic will also result in the loss of a green verge and some lovely mature trees being felled and will also reduce the green space and parking for the residents of Chertsey Court, we were assured at the developers meeting that we would not lose any parking space.

We are extremely disappointed that the revised plans show a cycle lane from the bus stop to Chalker's Corner itself.
