# Summary and Background

As local citizens we reject the planning submission as it fails to adequately address the concerns of the residents living directly on Lower Richmond Road and the wider community. Failure to address these concerns will have a hugely adverse affect on our livelihoods. In light of the Mortlake Brewery Redevelopment, we are in agreement there is a need to address traffic flows, bike lanes, pollution, parking and the environment, however this proposal falls way short. We feel the process and proposal lacks rigour and feel more consultation about the real issues and practical yet fully thought thru solutions need to be found.
