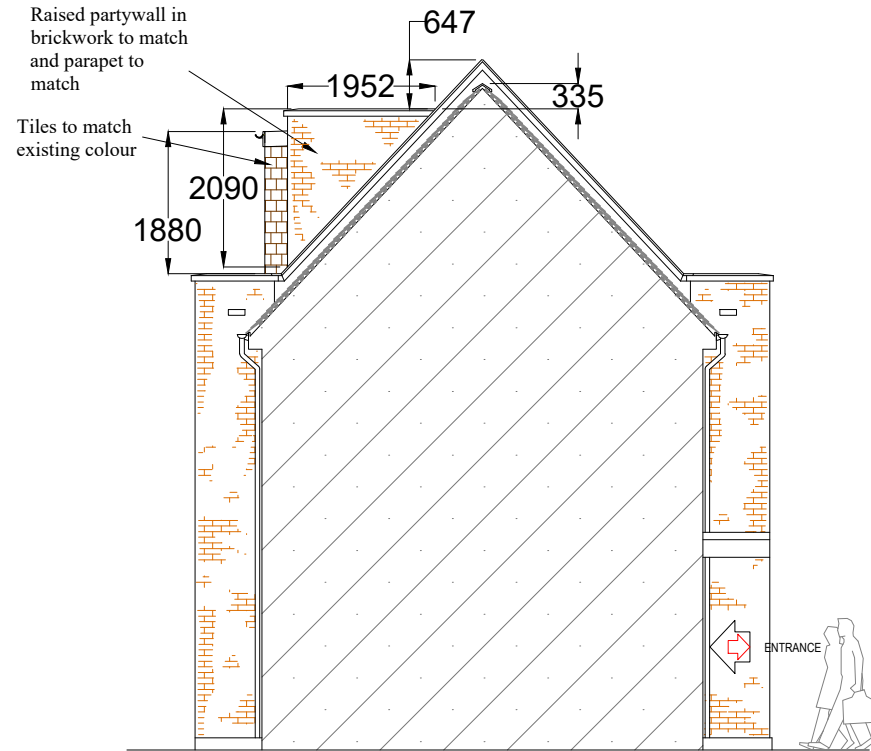

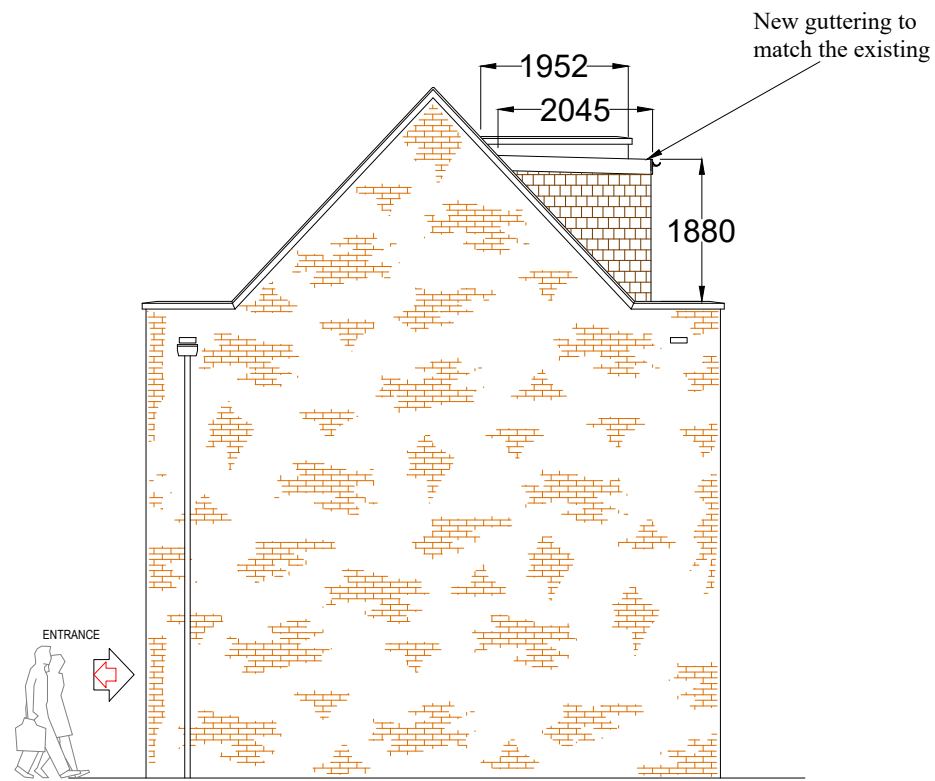

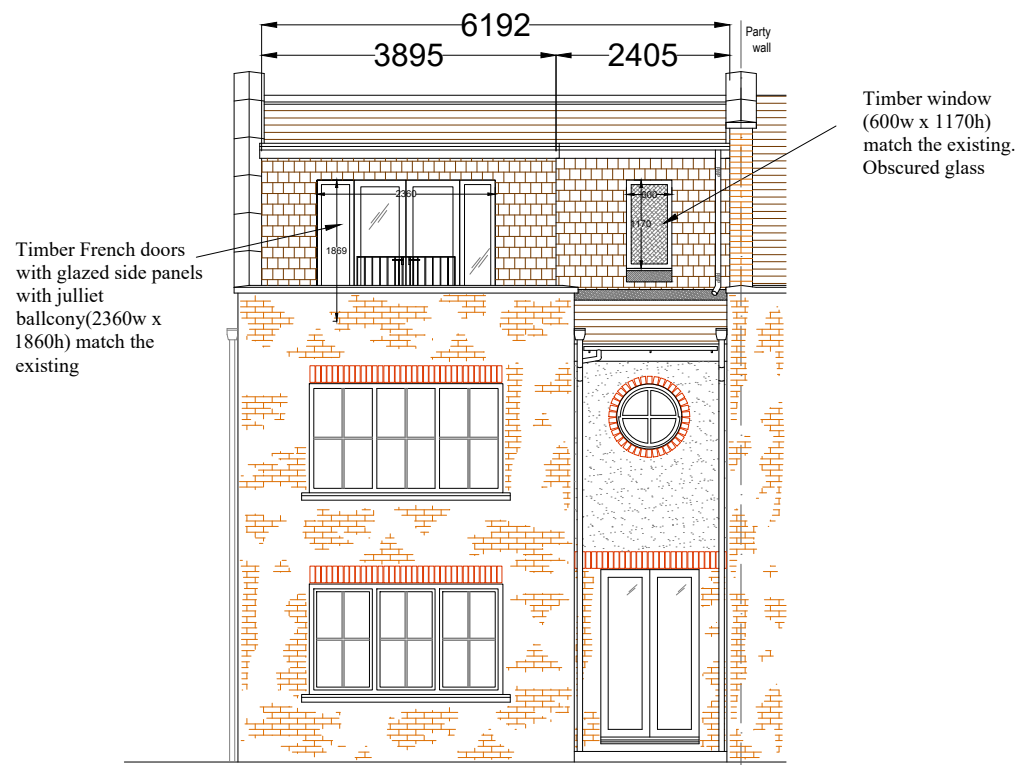
**PROPOSED SIDE ELEVATION (FACING WEST)**
