Volume of enlargement (including any previous enlargement) will not exceed 40m<sup>3</sup>. Materials are similar in appearance to the existing house. The proposed will not exceed the height of the existing roof. On the principal elevation of the house (where it fronts a highway), it will not extend beyond the existing roof slope. It does not include: verandas, balconies or raised platforms; or installation, alteration or replacement of any chimney, flue, or 'soil and vent pipe'. The eaves of the original roof are maintained and the extension is set back at least 20cm from the original eaves. The roof enlargement will not overhang the outer face of the wall of the original house.
