e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Felling of Ash tree - T1 because tree has died. After consulting with a tree surgeon it has been confirmed to me that the majority of the Ash tree at the rear of my garden has a fungus (Ash dieback), and only one small branch survives. The tree is approximately 20 metres tall with all the main branches lopped off, and no regrowth has taken place. The tree is preventing any development at the of the garden due the position of the trunk and large roots that close to the soil surface which spread throughout the garden. I intend to replace the tree with a smaller fruit tree.
