### 13. Pre-application Advice

Details of the pre-application advice received

Generally the comments were positive. Reference was made to reducing the eaves height of the flat roof to 2.2m. This would not be possible while keeping an acceptable ceiling height with a flat roof. Therefore the roof design has been changed to a pitched roof which allows for the reduced height eaves and provides a more sympathetic solution.
