1. INTRODUCTION

Single storey rear extension, 6m in depth, 3m in height and 3m in height to eaves.

The proposed development fails to comply with Condition A.4(3)(b) of Part 1 Schedule 2 where the developer has provided insufficient information to enable the authority to establish whether the proposed development complies with, the conditions, limitations or restrictions applicable to development permitted by Class A which exceeds the limits in paragraph A.1(f) but is allowed by paragraph A.1(g) of Class A and Part 1 Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015 and consequently Prior Approval is Required and Refused.

- **21/0872/PDE** - Single storey rear extension (6.00m depth 4.00m eaves height 4.00m maximum height). **Refused.**
- **07/0833/HOT** – Single storey rear extension. **Granted Permission**
