Whilst there are no in-principle objections to a dormer on this dwelling, as submitted the hip to gable and dormer appear awkward in relation to the existing roof. Given the altered roof forms in the locality, to achieve the desired accommodation at roof level, the applicant is advised to explore the option of a replacement roof with gable ends, similar to schemes seen further along the street. The proposed works would be located within the confines of the existing roof. Thus, the proposed development is not anticipated to appear unreasonably overbearing or visually intrusive to neighbouring occupiers. The siting at roof level would ensure the extension would not cause an undue loss of light to neighbouring properties habitable rooms or gardens. It is acknowledged that rear dormers are not common with the immediate locality. However, giving notice to the existing situation, positioning and orientation of the site, no harmful overlooking impacts are anticipated. The upper floor rear elevation windows offer an existing degree of mutual overlooking between properties. The proposed fenestration is unlikely to further increase this. The proposal would not cause any loss of amenity space.
