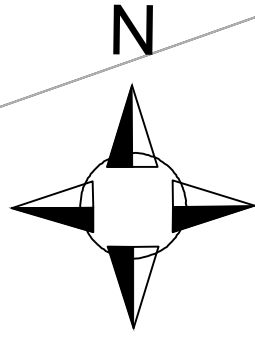




Proposed extension outline.

- All works if applicable, must comply with current Building and Water Regulations.
- The contractor has ensured, during demolition work, no distress or movement to walls, floors and roof to the subject and adjoining building.
- All structural concrete to be grade C35 UNO
- All Structural steel to be grade S275 UNO.
- All Steel to be covered with 2 layers of 12.5mm plasterboard to achieve 30 min fire resistance.
- All supporting walls and structural works to be read in conjunction with structural engineer's details. structural steelwork (where used) to meet current building regulations.
- This drawing has been prepared solely for the purposes of obtaining either Planning Permission and or Building Reg approval. Unless marked as such (In Red) the drawing is not suitable for construction purposes, and it may be necessary to augment and / or amend the drawing for this purpose.
- No liability will be accepted for any omission or inconsistency should this drawing be used for construction by contractors without written consent from AA Drafting Solutions Ltd.

The client must abide by the Construction Design and Management Regulations 2015. The client must appoint a contractor, if more than one contractor is to be involved, the client will need to appoint (in writing) a principal designer (to plan, manage and coordinate the planning and design work) and a principal contractor (to plan, manage and coordinate the construction and ensure there are arrangements in place for managing and organising the project).
