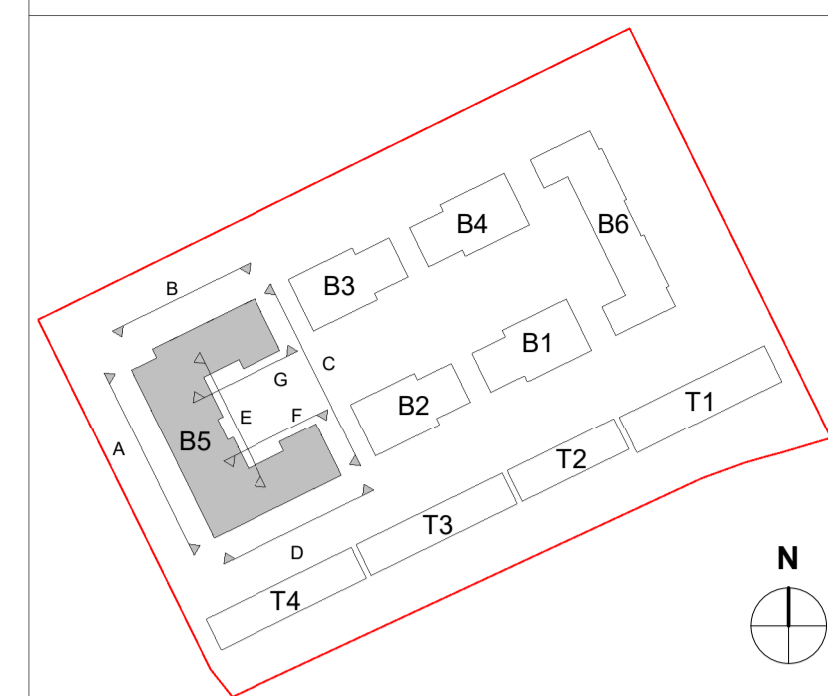


**Key Plan (NTS)**
