Comment: I welcome the development of the Stag Brewery site in principle. I object vehemently to the plan for a secondary school next to the brewery site. I do not know whether another secondary school is needed in Richmond but it cannot be sited on the lower Richmond Road where the traffic density is already severe and where the back up onto Mortlake High street, North Worple Way and up into Sheen Lane is unsustainable. the Mortlake station train crossing adds to the challenge with already dangerous levels of pedestrians waiting to cross, particularly at school hours to get to Thomson House, and competing with cars at that point. the communications infrastructure in that part of Mortlake simply cannot support the influx morning and outflow evening of the number of pupils and associated staff and support workers when the area, with Hammersmith Bridge still shut, is already over congested. Environmentally - the impact on air quality, and noise, also need to be factored in. Please do not approve the siting of the school next to the brewery development.
