as per TWO 01FX attached:

All trees are in the private garden of the Keepers Cottage. The woodland gardens around the cottage are currently being restored, with an accent on the removal of non-native species such as rhododendron.

All the Lawsons Cypress and Leylandii identified here to be felled are species inconsistent with the predominantly native planting of the Woodland Gardens.

Planting of native species is currently underway throughout the woodland gardens as part of its restoration and improvement.

Additionally 14KK is a grown out hedge feature which is very close to a building and may damage the foundations in due course.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
