1.1. This document provides evidence to show that there is an identified need for a nursery at the proposed site location. This document supports the planning application for the proposal: *Change of Use from Public House (Sui generis) to Children's Day Care Centre and Nursery (Class E) prepared for client Ms Jena Ntubma.* 

1.2. The nursery provides a crucial foundation for lifelong learning, helping children develop cognitive, social, and emotional skills. It fosters curiosity, creativity, and prepares them for formal education.

1.3. Given the current circumstances and present statistics and data showcasing the growing demand for quality nursery education due to changing family dynamics and the importance of early learning.

1.4. The demand for nursery education in the UK has surged due to the rise in dualincome families and recognition of early education's impact on future success. Statistics show enrollment rates increasing by 11% annually over the last decade.

1.5. Woodward Nursery is an experienced nursery school with plenty of experience and a unique curriculum. The proposed nursery stands out with a tailored curriculum that integrates play-based learning. The dedicated staff comprises early childhood education experts and the central location ensures accessibility. The state-of-the art facilities support holistic development.

1.6. Woodward Nursery, for the proposed location, has received overwhelming support from parents who value a focused learning environment. Local residents and authorities recognize the importance of prioritizing children's education and safety. Their Facebook page is currently active - reflecting the need for this nursery.

1.7. In this document we will identify existing nursery providers within a 1-mile radius of the proposed site location and demonstrate a number of nursery providers and number of children they can accommodate.

1.8. The total number of childcare providers will be compared with the number of children spaces and total occupancy rates of the identified nurseries.

1.9. Current childcare providers in the area are sorted by location from nearest to furthest from the site location.

Within a 1-mile radius of the application site there are 9 childcare nurseries identified.
 4 out of 9 identified operate only during term time, while the rest of them are full day all weekday nurseries.

2.1. It has also been noted that nurseries provide care for slightly different age groups but in general they are all within 0-5 years old group.

2.2. Furthermore, it can also be noted that in only 2 nurseries, the occupancy rate is below 50%. The rest of identified nurseries are at full capacity and barely can take more children in.

2.3. However, it must be noted that some of the data is outdated so this needs to be taken into account.

3. In general, taking into consideration the above data, it can be concluded that there is a need for more nurseries in the area. Therefore, this proposal for a change of use of a derelict vacant public house into a much-needed nursery in the area is considered acceptable development.
