Dear Lucy,

We have now heard back from Watermans on your comments on the draft views for the EIA and I set out their responses below:

- 1. **Viewpoint 1** refer to attached. We have now shown this view in two halves due to the very wide angle required in order to incorporate playing fields and Jolly Gardeners pub/BTM in context.
- 2. **Viewpoint 8 (now "Viewpoint 9")** We will ensure the final photography is taken from a location in front of the road sign. A few metres ahead of the previous location, adjacent to the zebra crossing and park entrance, should offer views towards both the hotel building and stack
- 3. **Barnes Bridge** Agreed, Barnes Bridge view does not necessarily assist the TVIA beyond those views already selected.
- 4. **Chiswick Bridge (now "Viewpoint 3")** Additional viewpoint to be taken from southern end of Chiswick Bridge within protected view. Viewpoint 3 illustrated by an internet screen-grab on the attached the location on the Richmond GIS map appears to be at the top of the steps. We will use this location in the final photography.
- 5. **Viewpoint 6 (now "Viewpoint 7")** refer to attached. Alternative location now shown, slightly to the east of previous, within protected view.
- 6. Views from Terrace We have looked at views from The Terrace and felt that the protected view from the vicinity of the White Hart pub (viewpoint 7 in the attached) is more useful for the assessment. From The Terrace buildings and vegetation tend to limit views, and further east on The Terrace the bend in the river and the intervening structure of Barnes Bridge diminish visibility of the site.

Please let me know if you have any further queries, or if these views can now be agreed and finalised?

Thank you for your email.

I have reviewed your document and have a couple of comments.

View point 1

- Was a photograph taken also looking towards the playing fields from this viewpoint? This area is likely to have significant change and therefore should be included.
- We were hoping to include any impact on the Jolly Gardeners PH BTM- it seems to be a bit side-lined in the view as shown. The building is something of a distinctive landmark

Viewpoint 8 - do you have a photograph in front of the road sign, which seems to be dominating the view?!

I did go back to Barnes Bridge, and noted that the views were not prominent from this location, given the river bend and also the footpath being on the east side of the bridge (see attached).


Finally, I did refer back to the Council's GIs system, and noted the following protected views (linear blue lines).

- I note Viewpoint 2 is covered by your document,
- For sake of completeness, could you please include one from the south side of Chickwick Bridge (I am sure you took a photograph from this location).
- I note that view 6 is just outside the protected view could you also cover this view?
- I also did note that when I visited Barnes Bridge, the view from the terrace may be more prominent given the increased level. (however, areas may be framed by trees so may not add to what is seen somewhat closer at the White Hart PH)










Viewpoint 1: View from Lower Richmond Road A3003 adjacent to main site access, looking north.














