Former Stag Brewery, Lower Richmond Road, Mortlake, London Appeal Against the Non-Determination of Applications for Planning Permission (Appeal A and Appeal B) London Borough of Richmond upon Thames refs: 22/0900/OUT and 22/0902/FUL PINS references: APP/L5810/W/24/3339060 & APP/L5810/W/24/3339062

On behalf of our client, Reselton Properties Limited (the "Appellant"), we have lodged simultaneous, conjoined appeals against the non-determination of two linked applications for Planning Permission refs: 22/0900/OUT and 22/0902/FUL at the Former Stag Brewery, Lower Richmond Road, Mortlake, London ('the Site'). The appeal references are APP/L5810/W/24/3339060 (Appeal A (previously known as Application A)) & APP/L5810/W/24/3339062 (Appeal B (previously known as Application B)).

The purpose of this covering letter is to help navigate the filing system on London Borough of Richmond upon Thames's website.

Appeal A




