This was a telephone conversation for a previous application to review the case officers comments on the design. During the call, the case officer stated the side extension at first floor level, to square off the building, and the addition of the new dormer was deemed to be a positive addition. The use of clay tiles to match the existing roof, with a stepped facade and material change around the proposed windows, to break the dormer up visually, was also deemed to be the positive and correct approach.
