Installation of a new shopfront to enhance the aesthetic appeal, improve functionality, and create a welcoming atmosphere for customers.

The windows will be equipped with white-painted aluminum frames and 12mm toughened clear glass. The stallriser will be crafted from solid Meranti wood, designed to replicate the original style. The shopfront frame layout will be reconstructed to match the existing design, and the door will be made from 12mm toughened glass as well.

Due to parts of the current shopfront being in a state of disrepair, it was necessary to replace the shop front to ensure the building's preservation and prevent further deterioration. The external works carried out will maintain the original appearance and aesthetic value of the facade.

These enhancements will not only stabilize and consolidate the structure but also ensure it is weatherproof, maintaining the building's collective significance and its historical integrity.

Moreover, these repairs have addressed significant safety concerns, correcting hazardous conditions such as falling wall sections, thus safeguarding public and child safety, while preserving the structural integrity of the building and preventing further damage.
