"Conservation Officers have reviewed the revised design. It is noted the current proposals retain the lightwell internally but propose a covering of the roof in glazing, which would maintain the roof form but still allow the aim of achieving greater light levels internally. The principle of this approach is considered more appropriate than previous proposals, as the volume and form of the building would be better retained and the glazing would potentially be less intrusive subject to final materials. Given the angle of the building to the street, the glazing would still be visible in views toward the site, and as the majority of the roof is proposed to be changed, it would alter the character and appearance of the building and read as a contemporary intervention. It would be more appropriate to flip the proportions of the retained roof vs rooflight, so that a greater amount of the roof is retained, and the panels are restricted in number and to the rear element. This reduces visibility as well as the amount of fabric lost. Currently the windows would partly illuminate the bin store which seems redundant, so they could be set back behind this. The glazing should be dark with dark frames so as to blend with the slate roof."
