NMA 5 Conditions: Separate contractors have been appointed for the demolition and construction phases of this project. This has caused problems regarding discharging pre-commencement conditions relating to both elements. Richmond Council have suggested amendments to 5 conditions to enable the demolition element to go ahead.

Amendments to 'Approved Plans' and 'Materials': Broadly both amendments are to accord with the terms of the application, for the avoidance of doubt and in the interests of proper planning.

Specifically for 'Materials', the original scheme proposed a timber cladding. However, Richmond Council have advised post design signoff that their insurance does not cover timber clad buildings. Consequently, there is a need to change the material to something that looks similar but isn't timber. Richmond Council have suggested wording to amend the 2nd condition listed on the decision notice.
