Summary of advice:

Windows - The proposed materials of the windows would be acceptable, as timber is the appropriate material for use in historic buildings and Conservation Areas. All aspects of the existing window design should be replicated, as noted in the Heritage Statement. If 24mm thick double glazed units are proposed and can fit into the existing boxes, this would be acceptable as the windows proposed to be replaced are relatively large one-over-one sash windows. [Note - the applicang is now proposing slimline double glazing, slimmer than 24mm.]

Door - As the front door is largely screened from all but close views by the existing low boundary wall and vegetation, and is partly screened from view in the street due to its positioning partially below ground level and under the existing porch, and it is considered the proposed door is of a similar design to others in the street and is an appropriate colour, there is no objection to the replacement of the proposed front door.
