T1 Oak- Deadwood and and tip reduce lowest branches to crown lift over the garden of 36 Sheen Common Drive to a height of 4m to allow safe access to the rear of the garden and provide sufficient clearance. Finished height 21m finished spread 10m.

  - adding other relevant features on the site (e.g. greenhouse, paths)
