

DETAILED REASONS

U0187057 Reason for Refusal - Transport / Access

In the absence of sufficient evidence to demonstrate that adequate arrangements can be made for offstreet parking and the storage and disposal of waste, such as not to result in detrimental transport impacts as well as impact to the safe and suitable acces to the site for all users, the proposals do not comply with condition MA.2(2)(a) Criteria 1a of Part 3 - Changes of Use, Class MA 'Commercial, Business and Service Uses to Dwellinghouses' contained within the Town and Country Planning (General Permitted Development) Order 2015 (as amended).

U0187056 Reason for Refusal - Natural Light

In the absence of sufficient evidence to demonstrate that natural light will be available to bedrooms 1 and 2, the scheme will be contrary to the requirements under condition MA.2(2)(f) of Part 3 - Changes of Use, Class MA 'Commercial, Business and Service Uses to Dwellinghouses' contained within the Town and Country Planning (General Permitted Development) Order 2015 (as amended).
