Please describe the non-material amendment(s) you are seeking to make

We are seeking to make alterations to the roof. The approved roof is a 7° lean to roof with 53% of glass. We are proposing to amend the roof to part flat roof and part 17° lean to glazed roof. This would result in a smaller percentage of 33% glass in the extension roof.

The brick flank wall was shown without coping stones, these have been adjusted and drawn with coping stones to provide weathering to the brickwork.

The footprint and the glazing to the rear will be the same as the current approved application.

The amendments have been suggested to assist with better weathering details, maintenance and to reduce the area of glazing in the new extension in line with Building Control requirements for part L conservation of fuel and power.
