Details of the pre-application advice received

Design change to the front elevation of the side extension to include for the larger set back

No objections are raised to the front elevation of the side extension. The 13000mm set back is considered acceptable as it is SPD compliant. It is noted that the applicant has asked whether this wall could be pulled forward by 300mm. This would be considered acceptable as it would retain a 1m set back which is the minimum required within the House Extensions and External Alterations SPD.

Materials confirmed

The tiles to the roof and the red brickwork to the side extension and to that of the altered roof to the garage are considered acceptable as they match the existing dwelling.

The proposed windows to the side extension match the design of those existing to the front and rear elevation. Although they are wider than those associated, the set back from the front elevation would mitigate the impact and the rear, the rear window is not considered too big. uPVC windows although not preferred, are acceptable in this instance due to the presence of uPVC windows on the existing dwelling.

The grey PVC fascia and grey PVC double glazed folding doors are considered acceptable as they are limited to the ground floor level.

The windows to the upper floors on the gabled side elevation should not only be frosted but should be should be fixed shut and this should be specified on drawings. A condition will also be attached to any permission to secure this.

Design of roof to side extension

The applicant has also stated that the side extension is now sitting flush with the garage rather than overlapping by 1500m. However, the updated drawings show the setback. Both options are considered acceptable.

Also received advice to reduce the scale of the rear extension on ground floor to 2.9 metres and side extension on the first floor to 1.5 metres which now is inside of the parameters.
