T2 Hazel (Corylus avellana) 30% Crown Reduction - Reducing the height and spread of the tree by approximately 2m to tidy and contain and retain

furnishing growth. Final height = 2m and final spread = 2m.

- T3 Hazel (Corylus avellana) Coppice at last points. Remove adjacent sycamore sapling. Final height = 0.5m and final spread = 1m.
- T4 Sycamore (Acer pseudoplatanus) Remove suckers from around base, including establishing saplings near boundary wall to east, adjacent to Patten

Alley. Coppice Hazel around base of Sycamore. Raise crown on sycamore to give 3m clearance. Lightly reduce where overhanging neighbour to south

and west. Final height = unchanged at 12m and final spread = unchanged at 8m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
