- T1 Elm (Ulmus spp) Reduce away from side / corner of neighbours at No.4 The Vineyard. Removing around 2-3m go give 2-3m clearance from building.
- T2 Horse Chestnut (Aesculus hippocastanum) Reduce away from side / corner of neighbours at No.4 The Vineyard. Removing around 2-3m go give 2-3m

clearance from building.

T3 Judas tree Raise crown over footpath to give 2.5m clearance. Reduce overhang to road back to in line with the edge of pavement. Lift away from the

stone ball pier cap and building roof to give 0.5-1m clearance. In all cases pruning to suitable growth points to maintain a natural looking form

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
