Removal of sedum layer and single-ply EPDM waterproof covering, and insulation to deck level, and replacement with new insulation and new felt waterproof membrane.							
Please state why you wish to make this amendment							
The building has suffered from water ingress over many years and investigations and attempted repairs have been hampered by the sedum layer. The existing sedum is difficult to access and maintain, and a significant proportion is dead. Removal and replacement of the roof will enable the Early Years Nursery to operate safely without the long-term levels of water ingress being experienced, and potentially pave the way for solar panels to be installed at a later date.
