T1. Cedar of Lebanon Rear garden Very large mature specimen tree holding a tree protection order. Previously reduced 4 years ago. To maintain cyclical pruning schedule, improve light into surrounding 5 gardens and clearance from adjacent property roof; Reduce canopy height by 2-3m and lateral spread by 2-3m via branch end thinning and "drop crotch" method as per British Standard 3998:2010. Remove deadwood, weak and suppressed branches. Crown lift over adjacent property to ensure 3m clearance from roof and side elevations.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - adding other relevant features on the site (e.g. greenhouse, paths)
