G1 x4/5 Ailanthus adjacent to the building: Reduce by 2-3m from all aspects to leave a finished height of approx. 7m and finished spread of approx. 4.5m

Reasons: To maintain at current dimensions, cut back from property, supressed trees, poor location for species

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
