The current approved design has a pitched roof with less than a 10 degree pitch. For construction the recommended minimum pitch for a roof is 20 degrees. We therefore request approval to increase the slope of the roof to 20 degrees to achieve a robust detail. The newly proposed design will not increase the height of the roof at ridge to more than 4m, and the height at eaves will remain as previously approved

With a revised roof angle the ridge height will increase slightly; all other construction details, materials and finishes will remain the same.
