T1 Magnolia × soulangeana Reduce back overhang to patio and height b 1-2m. Final height = 7m and final spread = 4m.
T2 Olive (Olea europaea) 20% Crown Reduction. Reduction the height and enread of the tree by approximately 1.2m to tidy and contain

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
