We seek to move the outrigger to a more central position so that the impact on No. 97 is reduced further and a more balanced look is achieved at the rear. The marginal increase to the width we are seeking will not have a detrimental impact on No. 93 as the outrigger still passes the 45 degree from the centre of the neighbour's window rule and overall remains well below half the width of the site.

If you wish the existing condition to be changed, please state how you wish the condition to be varied:

Currently the outrigger is setback 1000mm from No.97, the proposal will increase the setback to 1619mm but, it still remains 2775mm from the boundary of No.93; all other construction details, materials and finishes will remain the same. Update to new drawings P500 Proposed Ground and First Floor Plans, P501-Proposed Second Floor and Roof Plans and P502 - Proposed Elevations.
