I am providing photographs and a report from Greenwood Arboriculturalist and also their tree condition survey .

I made this application last year 2023. (23/T1045/TCA). In response on 10th January a TPO was served (T1214). Council officers visited my property on 1st May following which a decision was made to allow the TPO to lapse. I was not notified of this until 19th September when tree officer Jamie Albertsen called me. His email to me states:

I am writing to inform you that the Council has decided to allow the provisional Tree Preservation Order (T1214) relating to the trees at your property, 23 Montague Road, to lapse.

After careful consideration and assessment, it has been determined that the protection afforded by the provisional TPO is no longer deemed necessary.

The decision was made following a thorough review of the trees) and their contribution to the amenity of the area, alongside any relevant representations made during the consultation period.

As a result, the provisional TPO will not be confirmed, and no further legal restrictions will be imposed on the trees at this time.

Jamie Albertsen has been dealing with this. I advised Jamie that I do still need to remove the trees and he advised me to submit an another application .

2 x Robinia Pseudo Acacia at front of 23 Montague Road -to be professionally removed in full . Replaced with one healthy deciduous tree, as mature and high as can reasonably be obtained and planted , possibly maple or birch depending on availability.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
