Copper Beech (T1): Reduce crown by 2m as part of regular maintenance. Lift crown by removing lowest limbs to improve access and give vehicles clearance. Height after work, 9m. Width after work, 8m. Bay (T2): Take down 6m high multi stemmed bay in rear garden to increase light and give a better view of the magnolia behind it. Tree is to be replaced with an ornamental cherry.
