T1 Robinia (Robinia frisia pseudoacacia) Reduce 3 stems closest to front of building by around 2m below the recent reduction points.
Remove lowest limb over road. Ensure remaining crown is cut back to give at least 2m clearance from building. Final height = unchanged at 9m and final
spread = unchanged at 6m.
