Copper Beech T1 front garden.

Reduce height by up to 2m to suitable growth points.

Reduce width of crown by 3m to suitable growth points.

The tree will stand at 18m tall with a width of 10m.

Reason for works is to manage the size and overhang of branches into neighbouring property and street given its location in the front garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

 - o adding other relevant features on the site (e.g. greenhouse, paths)
