T1 Bay Laurel reduce canopy by approx 1m from tips leaving tree with height of 5m and width of 4m T2. Holly reduce canopy by approx 1m from tips leaving tree with height of 5m and width of 4m. T3 Acer reduce canopy back to previous reduction points leaving furnishing growth. Remaining tree height of 10m and width of 6m.
