Rear Garden of 30:

Reduce back all overhang to boundary (approx. 2.5m) to suitable growth points. The tree's current height is 11m and crown spread is 7m After the proposed works, the tree's height is 11m and the crown spread is 4.5m (NW-SE)

T4. Beech Tree

Rear Garden of 30:

Reduce back south-east flank of crown which overhangs garden of 32 by approx. 2.5m to suitable growth points, retaining lower growth for maximum screening.

The tree's current height is 17m and crown spread is 11m - After the proposed works, the tree's height is 17m and the crown spread is 8.5m (NW-SE)

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
