# 13/2102/DD25 Hampton Pre-Prep And Prep School, Gloucester Road, Hampton

# Site, history and proposal

13/2102/FUL granted planning permission for the re-development of school site comprising demolition of 3no. existing single storey teaching blocks, stores, the existing hall and construction of new two storey building with associated external works and landscaping, subject to various conditions.

This submission relates to condition U67172 (now W67172) which states:

That no more than 144 pupils shall be on the school roll at any one time and prior to the commencement of the first term of each year in September, the school roll shall be submitted to the Local Planning Authority to confirm such compliance.

Reason: to safeguard the amenities of neighbouring residential properties, to ensure a safe form of development in terms of traffic to & from the site & to accord with the terms of the application.

DD04 has already approved pupil numbers for 2014, DD06 for 2015, DD12 for 2016, and DD14 for 2017, DD16 for 2018, DD17 for 2019, DD19 for 2020, DD21 for 2021, and DD23 for 2022, and DD24 for 2023.

The current submission relates to the start of the autumn term 2024 and specifies that the number of children are 142.

# Public and other representations

None received

#### **Professional Comments**

The school have prepared letter stating that at the start of the Autumn academic term 2024, the number of pupils on the school roll is 142.

Condition U67172 required that no more than 144 pupils should be on the school roll at any one time and prior to the commencement of the first term of each year in September. The submitted letter from the Bursary at Hampton school confirms this to be the case.

As such it is appropriate to discharge condition U67172. This is an on-going condition which requires the school to submit the school roll each year in September.
